The City Clerk informed the council about the bills that are paid automatically and explained the claims report in the council packet. The council requested a report for each debit card user. Mindy Fox moves to have the debit card limits as follows: Heath Roark - \$2,000, Dawn Paul and Jeff Canfield - \$1,000 with a second from Steve Knox. All in Favor. Motion Passes. Clerk Report: City Clerk Dawn Paul notified the council about the auditors being in the office on May 9th. She also brought up the Dodge Charger needing mechanical work. The council requested a third bid on the car. The council decided to talk about the car at a later meeting.

Public Works Report: Public Works Director Heath Roark wants to thank the Lutheran School kids for helping in front of the city hall, the Men's group for helping at the library flower beds and Jason Viebrock for the donating of the rock for the library flower beds. The city will send out thank you notes. Heath informed the council of a tree in front of Haundel House that lost a large tree limb and needs to be removed. David Locke moves to remove the tree with a second from Steve Knox. All in Favor. Motion Passes. He also informed the council that the city will begin purchasing the restrooms
